- The balance sheet and the income & expenditure account dealt with by this report are in agreement with the books of account.

Subject to the following remarks and general observations.

A. SIGNIFICANT ACCOUNTING POLICIES: -

- a) Basis of preparation of financial statements:
 - i) The financial statements have been prepared under the historical cost convention in accordance with generally adopted accounting principles.
 - ii) The trust has followed the mercantile system of accounting, except collection of fees from students on receipt / cash basis and interest on bank saving accounts is accounted as and when credited or received.
- b) The fixed assets are shown at cost of acquisition. The cost of assets includes other direct and indirect cost incurred to bring them to their present location and condition.
- All investments are shown at cost of acquisition.



B. The expenses pertaining to salaries and allowances of non teaching staff and other administrative / establishment expenses of this unit are the expenses incurred on the object of the trust and hence the same have been shown accordingly.

C. The Trust is registered under the Bombay Public Trust Act, 1950 at Ahmednagar in 1986 under registration number F-1053, Ahmednagar. The object of the Trust is to inspire education & not involving any activity of profit.
