From the tabulation its observed that, out of 408 files 38 files are recommended to update for quality enhancement of the institution.

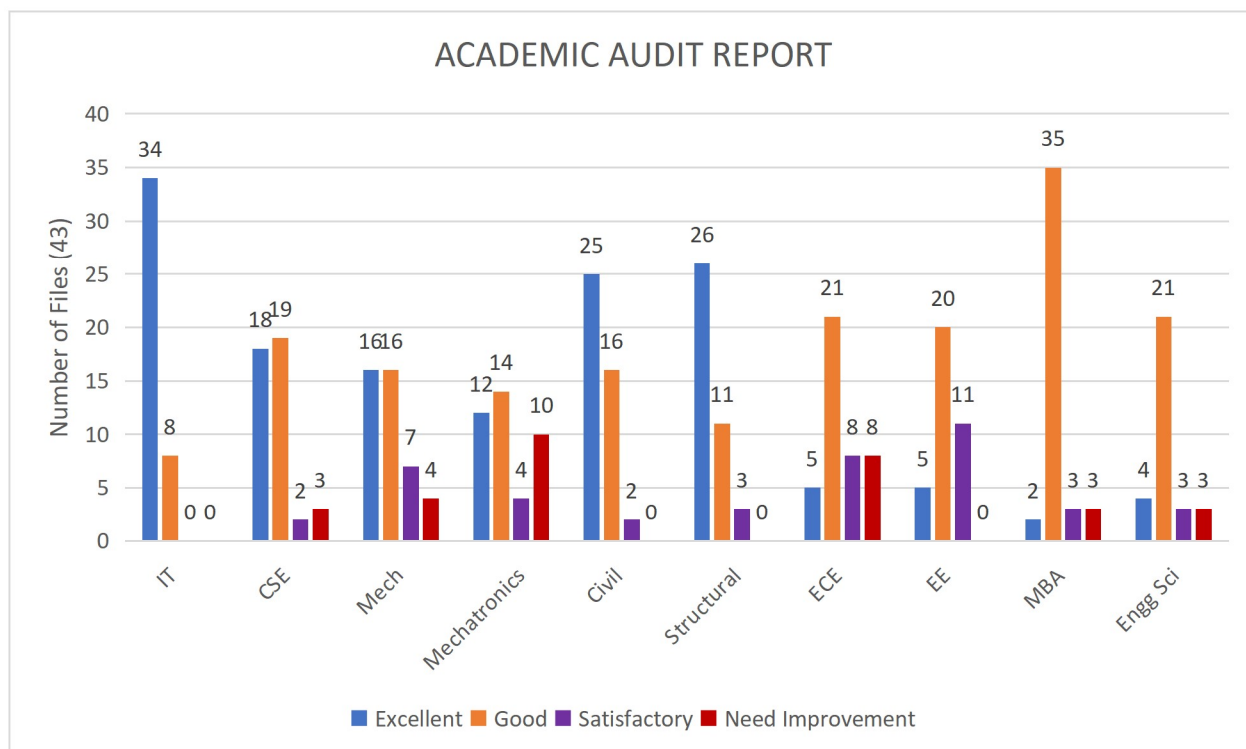

Figure 1 describes the average rating of the questionnaire. From each department audit feedback of the all department teaching learning process and activities for the academic year 2022-23, it was observed that **90.69 %** questionnaire have satisfied whereas **9.31 %** questionnaire have dissatisfied. The average dissatisfaction percent are less than 15 %, Since the percentage of dissatisfied files are below 15 %, there are no actions needed. Therefore, it is recommended that institute should have very good documentation to satisfy any accreditation committee.

#### Overall Assessment:

- Files are maintained and documented uniformly in all department
- More number of student activities are conducted as per plan
- Students Internships, Inplant Training and Industrial Visits are less
- Faculty Interaction with Industry/Academia is not satisfactory
- Patents are filed/published by the Faculty Members
- NPTEL Certifications are received by both Faculty and Students
- Consultancy activities are available in few departments
- Faculty publications in reputed journals are less
- Awards and Recognitions, Books/Chapters are minimum

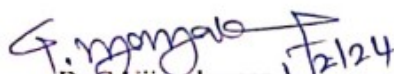
### **Suggestion:**

- Department should identify industries for students Internships, Inplant Training and Industrial Visits
- All faculty should be encouraged for research fundings and publications in reputed journals
- Student Awards and Recognitions need to be increased
- Conduct academic and outreach activities as per NEP 2020
- Teaching — Learning can be improved by using more No. of ICT tools
- Skill Development Courses should focus on industry requirements
- Industry Linked Laboratories should be planned for all departments
- Consultancy activities need to be done in all departments
- MoU's should focus with outcomes

### **Action Taken:**

- Teaching Learning has enhanced through Activity Based Learning
- Identified industries for students Internships, Inplant Training and Industrial Visits
- Faculty Visit to Industries/Institutions and Faculty Guest Talks are Improved
- Faculty contribution in academic activities like Publications, participation in Workshops/Seminars/FDP's, Funding Proposals, Awards and Recognition, Patent Filing and Books/Chapters are enhanced
